### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This permanent housing project, administered by the Core Service Agency of Harford County, Inc. under the MD Department of Health- Behavioral Health Administration, will continue to provide tenant-based rental assistance in Harford County to six (6) individuals and eleven (11) families who are experiencing homelessness or chronic homelessness and have at least one adult member who has a serious mental illness. Individuals identified as experiencing chronic homelessness will be prioritized for placement to non-dedicated chronic homelessness beds that become available through turnover. The CoC Housing Program rental assistance is matched with an array of support services. Consequently, due to consistent successful cost savings in past competitions, the project is projected to increase its capacity to serve participants in excess of the budgeted number being requested to meet the greatest need in the community.

In addition to serving the target population already noted, the project also limits barriers to housing for other sub-populations that include the following: veterans, victims of domestic violence, those with a co-occurring substance use disorder, HIV/AIDS, and those who have had encounters with the criminal justice system. With the assistance of a case manager, the participant will be able to select a housing unit of their choice located in scattered sites throughout Harford County from private landlords and property management companies. 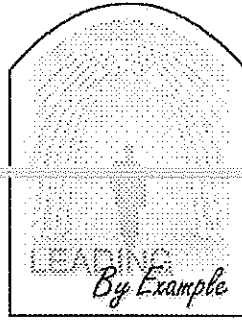

I am writing to express my support for the continuation of the Harford County Continuum of Care Program, formerly called Shelter Plus Care Housing Program. The Continuum of Care Program has been a valuable resource for Harford County citizens who have been incarcerated at the detention center, do not have a home, and suffer from a serious mental illness.

Leading By Example will provide targeted case management services for approximately 22 individuals/families for a total value of \$78, 731.40. These services will be available for the duration of one year for the period of July 1, 2019 to June 30, 2020 as a match for a grant with an unknown number at this time.
