### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

Harford Family House (HFH) provides an essential network of programs and supportive services focused on serving intact homeless families with dependent children. HFH is the only provider within the CoC that can keep a family intact if there is a father with the family. While participating in the program, each family must complete a working budget and a goal plan which includes the repairing of their credit history. Case management staff review individual budgets and goal plans quarterly with the families. The SHP at HFH only accepts families where at least one individual in the family has a disability. There is no time limit on their stay, but it is the project's goal to move the family on to self-sufficiency by aiding them in getting SSI/SSDI or a mainstream housing voucher. Clients are referred to SOAR, medicaid and/or ACA for insurance if appropriate. In order to tackle the barrier of credit, HFH staff assist families in working on their past credit and future credit challenges. HFH is located in Aberdeen, MD along the Route 40 corridor, one of the neediest areas of Harford County. The families in the program have easy access to public transportation, support services, the local health dept, schools, medical care and a wide variety of personal and business needs. HFH's apartments are well maintained. Client families are able to participate in the Steps to Independence Program, a series of seminars on various life skill topics such as budgeting, financial management, conflict resolution, general employment skills, etc. In addition to the monthly seminars, individual guidance is provided by the case managers or through referrals to appropriate topic area experts. The staff actively participates in our Harford Round Table monthly meetings as well as the working group subcommittee, "Point in Time Count". The staff are committed to daily usage of the HMIS software program and maintain strong records and case notes on their homeless families. HFH partners meet on a regular basis with many local agencies to assist their client families with receipt of eligible benefits, job training and basic needs. Funding for the HFH PH I will serve a total of six families - seven adults and fourteen children.
