United Way of Central Maryland has been a key player in providing services to those who are chronically homeless. UWCM's Permanent Supportive Housing has a dedicated case manager and an array of other services that can be accessed by the participants. UWCM's caseworkers and staff are extremely knowledgeable in assisting individuals in developing their own goals, e.g. obtaining entitlements, linking to appropriate outpatient treatments, assisting with medication, accessing needed medical appointments, locating employment opportunities, developing community support systems, and accessing community prevention programs with other existing agencies. UWCM administers 24 units of housing for people who have been chronically homeless. UWCM is a participant in the coordinated access process and receives all referrals through this entry point.
