To: Harford County Housing Agency Housing Choice Voucher Program's Notice to (Section 8) Landlords, Tenants, Partners, and the General Public

The Harford County Housing Agency's Housing Choice Voucher Program ("HCV" or "Section 8") Office located at 15 South Main Street, Bel Air, MD, 21014 will be changing its normal operating procedures starting Wednesday, March 18, 2020 through Tuesday, March 31, 2020. In response to the most recent developments of the pandemic Novel Coronavirus (COVID-19), we have established the following:

- There will be no appointments, walk-ins or inspections until further notice.
- HCV Program Participants should make every attempt to send in their recertification paperwork via fax, email, or mail. Contact your Housing Analyst to discuss the best approach to completing your recertification or interim certification.
- Housing Analysts will be reaching out to HCV Program Participants who have recertification appointments or initial briefings for the remainder of March and early April to brief them on how to conduct their recertifications or reschedule.
- If you have a scheduled HAP Contract signing or a unit that recently passed inspection, you will receive instructions from the Analyst assigned to your account.
