I attended the Redistricting Commission meeting last night and notice the attached map that they put up on the TV screens. The numbers were very interesting as they now show District A numbers and all the other Districts and shows we are the largest populated District in the County by far. The map now shows that District A should now have the adjustment that we could not make about 10 years ago when I was on the Council. The numbers than would not work though many people within the District would like that to happen. That is if you look at the map of District A to the north you will see a piece of land that goes up into Abingdon that we call the "Panhandle". It clearly does not belong in District A as they have little to nothing to do with Joppatowne or Edgewood. It even looks peculiar when you look at the map. However I understand, from going through this process, that the numbers must work. I believe they now will. District A has 45,987, a 2,409 person growth, District B has 42,834, a -744 person decrease also District C has 41,785 a - 1793 person decrease and finally District F has 41,467, a - 2,111 person decrease. I use these District because they either touch this piece of land or are very close. Districts B or F would be the logical choice. That would make District A approximately 41,987 and District B 46,834 or District E 45,467. Given the number of 4000 people that live in the "Panhandle", according to the Redistricting Commission. I spoke at this hearing last night and made the Commission aware of this unbalance. They did say they were looking at this and were trying to make it work, but there were a lot of people who live in that area that made it difficult.
